DECLARATION OF LOWEST CALCULATED BID FOR THE DESIGN AND BUILD OF INFRASTRUCTURE PROJECT FOR SEWAGE TREATMENT PLANT (STP) FOR THE PHILIPPINE SCIENCE HIGH SCHOOL DILIMAN PROPERTY

WHEREAS, General Appropriations Act of 2020 approved the abovementioned infrastructure project of Philippine Science High School-Main Campus;

WHEREAS, the Approved Budget for the Contract (ABC) is **Twelve Million Pesos Only** (Php 12,000,000.00);

WHEREAS, the title of the project is "Design and Build Project of Infrastructure Project for Sewage Treatment Plant (STP) for the Philippine Science High School Diliman Property";

WHEREAS, the Bids and Awards Committee for Infrastructure advertised the Invitation to Bid for the Design and Build Project of Infrastructure Project for Sewage Treatment Plant (STP) for the Philippine Science High School Diliman Property in Philippine Government Electronic Procurement System (PhilGEPS), PSHS-MC Website, and BAC bulletin boards in the premises of PSHS-MC from December 4-23, 2020. The deadline for the submission of bids was on December 23, 2020 at 7:45 a.m. via Google Meet;

WHEREAS, in response to the advertisement, one (1) prospective bidder responded to the Invitation to Bid by attending the pre-bid conference on December 11, 2020 at 8:00 a.m. via Google Meet, namely:

WHEREAS, on December 23, 2020, during the scheduled opening of bids, two (2) bidder submitted their bid proposal on the prescribed date and time. The order of the bids opened were as follows;

- 1) Fluid System and Design Inc.
- 2) I.M. Bongar & Co., Inc.

WHEREAS, on December 23, 2020, the Bids and Awards Committee for Infrastructure opened and screened the Eligibility, Technical, & Legal Documents of the bidders. After the screening, only one (1) bidder passed the technical, eligibility and legal requirements;

WHEREAS, Fluid System and Design Inc. was declared as "failed" due to submission of unsigned PCAB License under Eligibility/Legal documents even all of the pages were certified signed by the company and due to non-submission of PRC I.D. and PTR copies of their key personnel;

WHEREAS, I.M. Bongar & Co., Inc., was marked "passed" on the Eligibility/Legal Documents and the Technical Documents and the chairperson proceeded on the next part of the bidding process which is the opening of financial envelope;

WHEREAS, the Bids and Awards Committee for Infrastructure opened Financial Proposal of the bidders and the BAC Chairperson read and announced the bid of the bidders;

WHEREAS, upon careful examination, validation and verification of all eligibility, technical and financial requirements, I.M. Bongar & Co., Inc. was declared the Single Calculated Bid with the total bid amount of Eleven Million Nine Hundred Twenty Thousand Seven Hundred Fifteen Pesos and 63/100 Only (Php11,920,715.63);

NOW, THEREFORE, WE, the Members of the BAC, by virtue of the powers vested on **US** by law, hereby **RESOLVE**:

- a) To declare I.M. Bongar & Co., Inc., as the Single Calculated Bid (SCB) with the total bid amount of Eleven Million Nine Hundred Twenty Thousand Seven Hundred Fifteen Pesos and 63/100 Only (Php11,920,715.63).
- b) To recommend the **post-qualification of I.M. Bongar & Co., Inc.** in accordance with Section 34 Rule X of the 2016 Revised IRR of R.A. 9184 to determine its responsiveness to the eligibility and bid requirements.
