#### **BID BULLETIN NO. 1**

This Bid Bulletin No. 1 is hereby issued to modify or amend items in the Bid Document with Solicitation No.: 22-11-115 for the **Provision of Security Services FY 2023.**

If a bid price, as evaluated and calculated in accordance with this IRR, is higher than the ABC, the bidder submitting the same shall be automatically disqualified. There shall be no lower limit or floor on the amount of the award."
