BID BULLETIN NO. 1

This Bid Bulletin No. 1 is hereby issued to modify or amend items in the Bid Document with Solicitation No.: 22-11-115 for the **Provision of Security Services FY 2023**.

In the Pre-Bid Conference for the above-mentioned project conducted last November 21, 2022, the following items in the bidding documents are hereby revised as follow:


